Item 5: HACC Better Practice Project call for examples

Ageing, Disability and Home Care (ADHC) is seeking examples of better practice in HACC as part of The Better Practice Project.

The project is an Ageing, Disability and Home Care (ADHC) priority initiative that aligns with:

- the NSW HACC Triennial Plan 2008-2011;
- the NSW State Plan priorities of embedding early intervention into government services and reducing avoidable hospital admissions; and
- international evidence supporting a person-centred, strengths-based enabling approach to service delivery.

ADHC wants to showcase practical examples of better practice from every ADHC Region, and is encouraging service providers large and small and peak bodies to participate in the mapping initiative lead by Alt Beatty Consulting.

Better Practice includes HACC services or programs that:

- focus on each client and carer's strengths and abilities;
- respect and embraces a person's autonomy and independence;
- considers each client's goals and tries to achieve them with short term support;
- promotes health and restores client functioning through a 'use it or lose it' approach and by doing things with each client rather than for the client; and
- supports each client and carer's connections to the community.

Regional Demonstration projects are also being run in the Northern, Hunter, Metro North and Metro South Regions which will demonstrate an early intervention approach for selected frail older adults who have a willingness to participate and the capability of improving functioning in the short term (6 to 12 weeks).

Item 8: New legislation for Voluntary Out-of-Home Care

New legislation within the Children and Young Persons (Care and Protection) Act for Voluntary Out-of-Home Care (VOOHC) was proclaimed on 24 January 2010. VOOHC includes centre-based respite care, host family care, or residential placements.

The recent Special Commission of Inquiry into Child Protection Services in New South Wales recommended that legislation be introduced to better safeguard the interests of children and young people in voluntary out-of-home care (VOOHC), many of whom have disabilities.

Principal provisions of VOOHC legislation

- Sections 135, 135C and 156-156A of the Children and Young Persons (Care and Protection) Act 1998 ("the Act"); and
- Clauses 40C-40V and Schedules 4 and 5 of the Children and Young Persons (Care and Protection) Regulation 2000 ("the Regulation")

Key changes

- Services that provide VOOHC need to be registered with the Children's Guardian.
- Services that provide VOOHC need to input information onto a Register being developed by the Children's Guardian each time a child or young person accesses VOOHC.
- If a child or young person stays in VOOHC for more than three months in a 12 month period, the placement needs to be supervised by a designated agency.
- If a child or young person stays in VOOHC for more than 180 days in a 12 month period, the supervising designated agency needs to ensure a formal case plan is developed to meet their needs.

The new legislation applies to all government and non-government organisations that provide or arrange VOOHC in NSW, irrespective of who funds those arrangements (private, NSW, Australian or Local Government).

The Children's Guardian have written to organisations that provide or arrange, or may provide or arrange, VOOHC advising them about the new legislation and the requirements of the new VOOHC system. They have also written to organisations representing parents and carers. Those organisations have been provided with the following information as applicable:

- Resource Kit for Designated agencies;
- Resource Kit for non-Designated agencies; and
- Information for parents and carers kit.

It is important to note that organisations that were providing or arranging VOOHC immediately before 24 January 2010 are automatically registered to provide or arrange VOOHC until 24 January 2011.

In relation to the VOOHC Register currently being developed by the Children's Guardian, VOOHC agencies will only have to enter information into the Register in respect of those children who are in VOOHC provided or arranged by the agency at or after the time the Register is operational. However, the Children's Guardian may request that the agency provide it with information in respect of any placements that concluded between 24 January 2010 and the Register becoming operational. The Children's Guardian may then enter this information into the Register.

Item 9: Sustainability Tool Selector: A Guide for Local Government – now available

The LGSA has released a new guide that will help councils break through the jargon surrounding sustainability and find out how they can improve the way they operate.

The guide is intended to save time spent researching tools and help reduce confusion about the differences between the tools.

The Sustainability Tool Selector: A Guide for Local Government was developed by the Institute of Sustainable Futures at the University of Technology Sydney, on behalf of the Urban Sustainability Support Alliance (USSA).

The guide showcases ten tools that can help council staff with evaluation, decision making, developing performance indicators and tracking progress towards sustainability at an organisational and project level. Case studies show how the tools have been used in practice by NSW councils, with a focus on resources required and outcomes achieved.

Guide launch

The tool will be launched in Sydney on 18 March. Attendees will hear about 10 tools from councils who have used them and meet the organizations who developed them. Allan Jones MBE, now City of Sydney, and the man who took Woking Borough Council in England off the electricity grid and introduced solar and tri-generation power, will be the key note speaker.

Hard copies of the Guide will be sent to all councils and will be available to participants at the launch.

Item 13: Integrated Planning and Reporting Update

The Local Government (General) Amendment (Planning and Reporting) Regulation 2010 commenced on 1 March 2010.

The Ministerial Order identifying those councils placed in Group 1 for implementing the new planning and reporting framework has also been gazetted. The list of councils identified in groups 1, 2 and 3 is available in the Division of Local Government (DLG) Circular to councils 10-04 dated 26 February 2010.

The amendments to the Regulation will apply to Group 1 councils from 1 July 2010, Group 2 councils from 1 July 2011 and Group 3 councils from 1 July 2012.

Councils are reminded that they are required to comply with the requirements in the Planning and Reporting Guidelines for Local Government in NSW, released on 21 January 2010. A support manual is also available to help councils implement the new requirements. The Guidelines and Manual are available on the DLG website

Item 14: Review of the role of Special Constables

The Department of Premier and Cabinet, Law Enforcement Policy Branch, has announced a review of the role of Special Constables.

In NSW, Special Constables are appointed to undertake a range of law enforcement duties, but they are not sworn NSW Police Force Officers.

There are currently more than 4100 recognised Special Constables in NSW. Approximately half are serving police officers from other jurisdictions, followed by NSW Police Force employees and employees of other NSW law enforcement bodies and government agencies such as RSPCA inspectors, councils and Area Health Services.

In February 2010, the NSW Government approved the release of the discussion paper, 'Special Constables: a case for reforming the current system for consultation. The discussion paper is available in PDF form from the Associations.'

As Special Constables in NSW may perform vastly different roles for different employers, the discussion paper proposes a multi-tiered solution to ensure that Special Constables are granted a suite of powers commensurate with their duties.

The Associations are seeking feedback from all councils so as to provide a whole of Local Government submission to the review.

Item 15: Council Accreditation Scheme to Commence

The statutory framework for the accreditation of council employees as 'council accredited certifiers' has commenced.

From this date, the Building Professionals Board will be able to issue certificates of accreditation to employees of council who carry out building certification work.

In summary

- Councils have six months from 1 March 2010 to ensure they have sufficient numbers of accredited certifiers to undertake all building certification work.
- Council accredited certifiers have a year's free accreditation and reduced fees after this.
- A three year transition period has been provided to allow all officers to be accredited – and time for employees to graduate to more senior levels of accreditation.
- A new Category A4 – Building Inspectors has been introduced to create a pathway for trainees to enter the industry.

Details of the amending legislation and a summary of the new accreditation scheme are available from Department of Planning Circular PS 10-003 dated 26 February 2010 on the Department of Planning website.
